ITEM 3 Utilisation of Funds – Sitting MPs

Lok Sabha - Financial status and utilization of funds is given in **Annexure-1**. Out of Rs.218.90 crore received so far from GoI, only Rs.203.95 crore has been sanctioned and out of which an expenditure of Rs.174.00 crore has been incurred. Overall average Utilisation %age over funds available is 79.48%. The Districts Amritsar, Faridkot, Gurdaspur, Hoshiarpur, Ludhiana, Sangrur and Fatehgarh Sahib have less utilization than overall average utilization.

Rajya Sabha - Financial status and utilization of funds is given in **Annexure-2**. An amount of Rs.131.13 crore has been received and 123.01 crore has been sanctioned and out of which an expenditure of Rs.105.32 crore has been incurred. %age utilization over funds available is 80.31%. The Districts Mansa and Sangrur have less utilization than overall average utilization.

ITEM 4 Utilisation of Funds – Ex MPs - Annexure-3 & 4

Upto 14th LS - All works of 14th LS were to be completed by 30-9-2010 as per the directions of MOSPI, GoI At present 64 works are under progress as per the reports sent by District Authorities. DyESA's of Amritsar-3, Ferozepur-10, Jalandhar-2, Ludhiana-27, Fatehgarh Sahib-21 and Sangrur-1 to complete these works without further delay as the accounts of previous MPs has to be closed and unspent amount transferred to sitting MPs as per GoI guidelines.

Ex RS - An amount of Rs.10.55 lac is still unutilized and DyESA's of Ludhiana, Patiala & Fatehgarh Sahib are directed to take necessary action.

ITEM 5 Online MPRs

Position as on 30-11-13

District Authorities are uploading Monthly Progress Report on GoI Website regularly every month.

ITEM 6 Computerisation – Annexure-5

As on 30-11-2013 out of 77486 sanctioned works, 76597 (98.85%) works have been uploaded on GoI website. All DyESA's are directed to ensure that all sanctioned works are uploaded on the MPLADS website immediately and all entries are correct and up to date. Districts (Amritsar, Sangrur, Fatehgarh Sahib, Hoshiarpur and Ludhiana) have uploaded more works than the sanctioned works. DyESA of these districts are directed to correct the uploaded figures immediately.

ITEM 7 Enforcement of Provisions for development of SC/ST areas-Annexure-6 & 7

As per MPLADS guidelines MPs are to recommend every year works costing at least 15.00% of MPLADS funds for areas inhabited by SC population and 7.50 % of the areas inhabited by ST Population. As there is no ST population in the State, 22.50% of the funds are to

be sanctioned for SC areas. The detail of amount sanctioned in SC/ST areas are given in Annexure 6 for LS & Annexure 7 for RS MPs. Position on this count is not satisfactory in case of Nodal Districts Amritsar, Bathinda, Faridkot, Gurdaspur, Ludhiana, Patiala, Tarn Taran, Mansa and Sangrur. Concerned DyESA's may ensure that funds amounting to 22.50% may be sanctioned for SC areas.

ITEM 8 Setting up of Facilitation Centres - Annexure-8

As per the new guidelines, facilitation centre has to be set up in the nodal districts with the consent of Hon'ble MPs who can provide an amount of 5.00 Lakh out of their MPLADS funds.

Out of 14 nodal districts, facilitation centre has been established in Fatehgarh Sahib and Mansa and 6 MPs have given consent to set up facilitation centre where requisite steps are being taken to set up the same. 6 districts namely Rupnagar, Amritsar, Sangrur, Patiala, Hoshiarpur and Tarn Taran have reported that consent of Hon'ble MPs is still awaited. Concerned DyESA's may personally contact Hon'ble MPs for getting consent.

ITEM 9 CAG Performance Audit Report No. 31 of 2010-11

Out of 13 Paras, 12 paras have already been settled. As per CAG para 3.3 an amount of Rs 41.00 Lakh was to be recouped from the implementing agencies as the works were not as per the guidelines. Nodal Department took up the matter with MOSPI, GoI and relevant papers with full justification were sent to MOSPI, GoI and an amount of Rs 33.00 Lakh has already been settled and Rs 8.00 Lakh is still unsettled. The detail of works is as under:

1. Development of sitting facilities in DC Office Nawanshehar costing Rs. 3.00 Lakh
2. Construction of visitors rooms near camp office, DC office Faridkot costing Rs 5.00 Lakh.

Action Taken Report of DC Nawanshehar was considered by MOSPI and in the meeting held on 20/11/13 Economic Adviser took the issue. It was advised that Action Taken Report with full justification may be sent through Divisional Commissioner. In this connection DC Nawanshehar has already been requested to send Action Taken Report through Divisional Commissioner vide this office letter No.22766 dated 22/11/13.

Regarding work at Sr.No.2 either amount may be recouped or Deputy Economic & Statistical Adviser may also send latest Action Taken Report through Commissioner with full justification to MOSPI.

ITEM 10 Physical Monitoring of MPLAD Scheme under Phase V

Agriculture Finance Corporation (AFC) has conducted a study of MPLADS works in 7 districts of Punjab State i.e. SBS Nagar, Hoshiarpur, Moga, Pathankot, Sangrur, Faridkot and Muktsar. Monitoring reports received from MOSPI, Govt. of India during Nov., 2013. A comprehensive factual and action taken report in respect of each item/irregularity is sought by Ministry within 45 days. Concerned Dy. ESA's may be directed to send Action Taken Report within stipulated time.
