To meet the requirements of Planners and Administrators, Economic & Statistical Organisation, Punjab has made an attempt to bring out the various bases of State Domestic Product to single base of 2004-05 for comparison purpose based on the methodology provided by the Central Statistical Office, MOSPI, Government of India, New Delhi.

I express my sincere thanks to all the officers & staff associated with the preparation of this important publication.

**STATE DOMESTIC PRODUCT
BACK SERIES
1970-71 TO 2003-04**

BRIEF BACK GROUND:

Estimates of State Domestic Product are regarded as the most important single economic indicator to measure the economic development of a State. It measures in monetary terms, the volume of all goods and services produced within the boundaries of the state during a given period accounted without duplication. These estimates are prepared for various types of economic activities according to a standard methodology provided by Central Statistics Organisation (CSO), New Delhi. These estimates depict the level of development and are useful for proper planning, evaluating progress and inter-state comparisons and as such are a valuable tool in the hands of planners and policy makers. The State Domestic product takes into account exclusively the economic activities, whereas non-economic activities fall outside its preview. Thus the household services rendered by family workers such as one teaching his own children and unrecorded productive activities performed by producers outside their own trade have not been accounted for under the State Domestic Product. These activities have been classified into 15 main sectors.

For the first time, Economics and Statistical Organisation, Punjab estimated the NSDP in 1967 with base year 1960-61 at constant prices as per the methodology provided by the Central Statistics Organisation (CSO), New Delhi. With the gradual improvement in the availability of basic data over the years, a comprehensive review of methodology for SDP estimates has constantly been undertaken by the DES with a view to updating the database and shifting the base year to a more recent year by following the methodology and the guiding principles of

the CSO, New Delhi. As a result, base years of the SDP were shifted from 1960-61 to 1970-71 in 1978, from 1970-71 to 1980-81 in 1988, from 1980-81 to 1993-94 in 1999, from 1993-94 to 1999-2000 in 2006 and from 1999-2000 to 2004-05 in 2010. Along with the shifting of base years of SDP series, the DES had also been making improvements in the compilation of SDP series, in terms of coverage of activities, incorporation of latest datasets and latest guidelines provided by the CSO, New Delhi.

IMPORTANCE OF LINKED SERIES:

Whenever a New Series of State Income is introduced within an updated base period, it is customary to link the old series to the series on the new base period. Until and unless the estimates are at the same base, they cannot be compared. In the context of Economic Development State Domestic Product (SDP) or State Income plays a vital role in formulating the policies of the State Government. State Income is one of the most important indicators for measuring the economic health of the State and also to study the over all impact of various developmental activities carried out by the state. If these estimates are available fairly at long series, the transformation of economic scenario will be known. It could facilitate the planners, policy makers, and administrators in formulation of plans.

METHODOLOGY:

The base year is to be shifted to more recent base with a view to capture realistic growth of the economy. The different base years deployed in estimation of State Income of Punjab are in line with the estimation of National Income (All India) are 1970-71, 1980-81, 1993-94 and 2004-05 series respectively. Whenever a series with new base is introduced, steps were taken to cover the new areas by improving the

methodology and old bases are to be brought to new base to have a time series data over a long period with uniform base for comparison and to arrive at meaningful conclusions.

For compilation of a linked series the available two standard concepts are:

- (i) The splicing method and
- (ii) Re working the estimates as per the current series methodology at the component or detailed items level. The major problems in compiling back series estimates is in maintaining the growth rates of earlier series (volume movements in the case of constant price estimates) at not only the component level, but also at each level of aggregation. If the growth rates are maintained at the component level, which means that there is a loss of additivity between the components and at the aggregate level. On the other hand, if the growth rates are maintained at the component level, and the aggregate is derived as a sum of the components, the growth rates of aggregates in the linked series will be different from those in the earlier series. This is because the weighting diagram in the new series is the prices of different components in the new base year. The growth rates of aggregates in the back years in the new series are now influenced by the prices structure of the new base year.

Keeping in view the above-mentioned difficulties in compiling the back series estimates, and the need to account for the expanded coverage and the new data sources in the linked series, the state has adopted the splicing method.

Growth Rates of GSDP/NSDP, GSDP/NSDP and Per Capita Income/Population of Punjab are given in statements. GSDP/NSDP by economic activity at constant prices from 1970-71 to 2003-04 are given in Annexures.

Limitations:

Since item-wise data under each sector of origin is not available from 1970-71 to 2004-05, splicing method is taken up at aggregate level.
